

St. Isidore School Tuition Assistance Program 2019-2020

The gift of a Catholic education, for many parents, is a choice often made at great sacrifice. For others, it is entirely dependent upon the receipt of tuition assistance. The availability of financial aid can be the deciding factor in choosing St. Isidore School, especially as tuition costs continue to rise. St. Isidore School maintains a Tuition Assistance Program, which provides limited financial assistance to families based on need and on an applicant's availability to assist in the school upon request.

Consideration for tuition assistance requires the submission of a Tuition Assistance Application and supporting documentation by the designated deadline. Please read the application carefully and complete it in its entirety, attaching the requested documentation and submitting the entire package on or before the referenced deadline. An incomplete application, missing documentation or an untimely submission will prevent evaluation of the application and result in the denial of the tuition assistance request.

- Criteria: Financial Need/Availability to assist in the School.
- Open To: Students entering Grades 1-8.
- Documentation required: Copies of 2017/2018 Federal Income Tax Returns (Form 1040), copies of 2017-2018 W-2 forms and /or 1099 forms, and copies of pay stubs indicating current year earnings.
- Available Date: Current students (grades 1-8): March 13, 2019
- Due Date for application to be returned: April 11, 2019 or sooner
- Return Completed application to: St. Isidore School Office in an envelope marked CONFIDENTIAL.
- Fee: Applicants will be responsible for any credit check fees.

Once submitted, the Tuition Assistance Application will be reviewed by both the Pastor and the Principal, and an applicant may be asked to attend a meeting with the Pastor and/or the Principal to review the application. In addition, an applicant may be requested to submit additional information or to clarify an issue in his/her application. If an applicant's financial situation changes and he/she no longer needs tuition assistance or no longer requires the same level of assistance, he/she is expected to notify the school about the change in his/her financial assistance needs.

St. Isidore School will notify applicants in writing about the status of their application.
